

AMENDMENT NO. 2 to
MASTER COOPERATIVE RESEARCH AGREEMENT
between
GEORGIA TECH RESEARCH CORPORATION
and
EMORY UNIVERSITY SCHOOL OF MEDICINE

WHEREAS an agreement having been made and entered into between the GEORGIA TECH RESEARCH CORPORATION, referred to as "GTRC", and EMORY UNIVERSITY, AND THROUGH ITS SCHOOL OF MEDICINE, referred to as "EMORY", relating to the Master Cooperative Research Agreement executed on June 24, 2022 and providing among other things for work to be performed by GTRC for EMORY, and

WHEREAS, it is now desired by both parties, that the term of the Master Cooperative Research Agreement be extended and Attachment A: Task Order Template be revised, and for these purposes.

NOW, THEREFORE, it is mutually agreed as follows:

- a. Section 2.1 is revised to read as follows: The duration of this Master Cooperative Research Agreement is extended from July 1, 2022 to June 30, 2027.
- b. Section 1.1 is deleted in its entirety and is replaced as follows: "Task Order" shall refer to the document which authorized performance of specific research under this Agreement Task Orders shall use the format provided in Attachment 4- and incorporated under Section 4,
- c. Section 4.1 is deleted in its entirety and replaced as follows Each Task Order for performance of the Cooperative Research Project conducted under this Agreement shall be in the form of the template Task Order, attached hereto and incorporated herein as ".4trachment A-1".

Except as modified herein, the terms and conditions of the aforesaid Master Cooperative Research Agreement shall remain in full force and effect.
